NOTICE IS HEREBY GIVEN that the polling locations listed below will be open from 7 am to 7 pm on Tuesday, November 4, 2025, for voting in a Special Election to adopt or reject the proposed Constitutional Amendments as submitted by the 89th Legislature, Regular and Special Sessions, of the State of Texas; The adoption of a local sales and use tax in the Village Mills Emergency Services District #8 at a rate not to exceed two percent in any location in the district.; The adoption of a local sales and use tax in the Tyler county Emergency Services District #6 at a rate not to exceed two percent in any location in the district.; The adoption of a local sales and use tax in Tyler county Emergency Services District No. 1 at a rate not to exceed one and one-half percent in any location in the district.

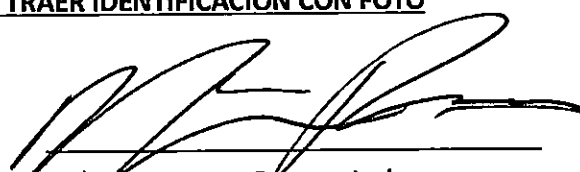
