

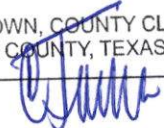

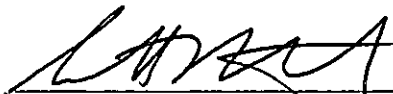
Notice is given that on the Date of Sale, Trustee will offer the Property for sale at public
